## **DEFENDANT BOND AGREEMENT**

**FOR AND IN CONSIDERATION OF A BAIL BOND BEING POSTED FOR MY JAIL RELEASE, I, \_\_\_\_\_, DO HEREBY AGREE TO THE FOLLOWING:**

### BAIL JUMPING AND FAILURE TO APPEAR

FAILURE TO APPEAR IN COURT MAY RESULT IN BAIL JUMPING CHARGES BEING FILED AGAINST YOU. BAIL JUMPING IS A 3<sup>RD</sup> DEGREE FELONY. A **3rd degree felony** is punishable by imprisonment for any term of not more than 10 years or less than 2 years and a fine not to exceed \$10,000.

- 1) Not to depart the court's jurisdiction without prior written permission from JUST BAIL BONDS.
- 2) To **IMMEDIATELY** notify JUST BAIL BONDS of any changes of employment, address, or telephone number.
- 3) To make an effort to retain an attorney and maintain employment.
- 4) I agree to check-in each week by PHONE at (817)795-5300 during normal business hours of 8:00 am to 8:00 pm beginning next \_\_\_\_\_ and each \_\_\_\_\_ thereafter until all bonds are exonerated.
- 5) I UNDERSTAND THAT IT IS MY **SOLE** RESPONSIBILITY TO KNOW MY OWN COURT DATES AND TO APPEAR AS DIRECTED BY THE COURT.
- 6) It is also understood that any balance due JUST BAIL BONDS must be resolved and paid before my final Court appearance.
- 7) I understand that if I am incarcerated on any other charge(s), it is a violation of this bond agreement.

A VIOLATION OF THE ABOVE CONDITIONS OF MY BOND AGREEMENT MAY RESULT IN THE IMMEDIATE ISSUANCE OF A WARRANT FOR MY ARREST, REVOCATION OF MY BAIL BOND AND ORDER OF DETENTION. ANY CRIMES COMMITTED WHILE ON BOND ARE GROUNDS FOR BOND REVOCATION.

### **ACKNOWLEDGEMENT OF DEFENDANT**

I acknowledge that I am the defendant in this case and that I am aware of all conditions of my BOND AGREEMENT. I promise to obey all conditions, to appear as directed, and to surrender for any sentence imposed. I am aware of the penalties if I should violate any conditions of my BOND AGREEMENT with JUST BAIL BONDS.
